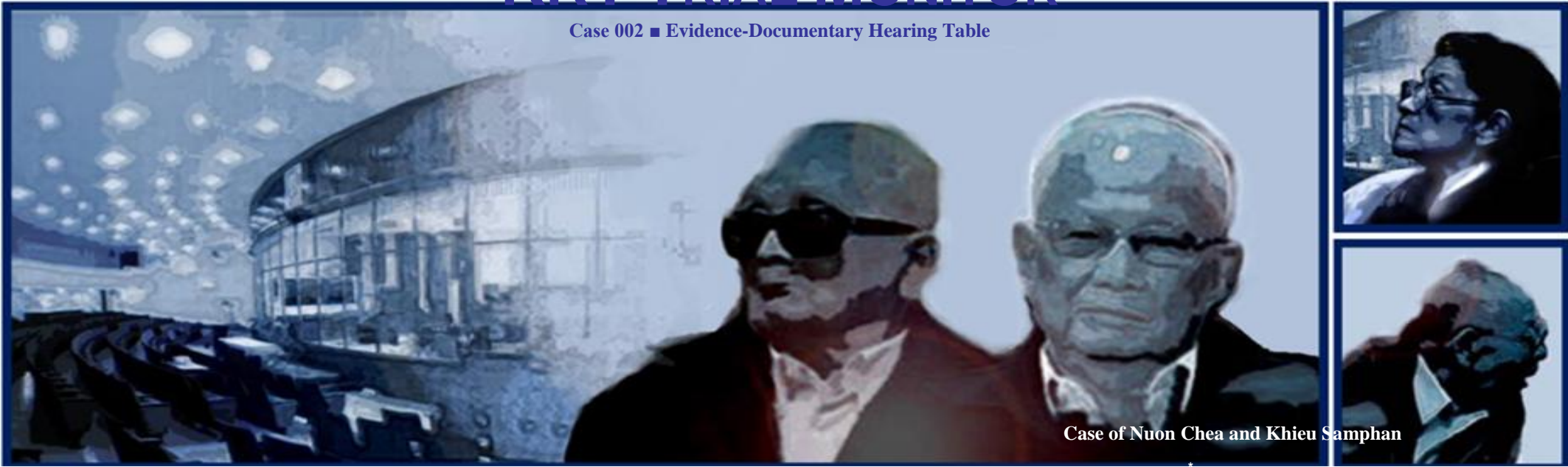

The Defense Team also objected to the presentation of Khieu Samphan's doctoral Thesis on Cooperatives.	The CPLCs withdrew Civil Party statements related to leng Sary from their presented list. The presentation of Khieu Samphan's doctoral thesis, according to CPLCL Pich Ang, was to show link to the link between it and the Central Committee's policy on Cooperatives. Additionally Khieu Samphan’s Defense also criticized the fact that the Defense were not allowed to argue on the admissibility and authenticity of the documents the OCP and Civil Party presented and could only comment on what probative value should be granted to them.</p> <p>On CPK Policy on Enemies Nuon Chea’s Defense held that CPK propaganda materials’ language should be seen as what it’s meant to be, namely rhetoric instead of literal. The word “Smash” did not always meant kill. This was also the same with the term “purge”. Nuon Chea’s Defense also stated that if radio announcement on the killing of only 7 super-traitors were considered by the Court, then the Chamber should see it as the proof that there was no policy to kill other Lon Nol’s officials. It was also inadmissible in the Court KR leaders’ awareness of how realistic the agricultural goals were, according to Nuon Chea’s Defense Team</p>	OCP claimed that documents pertaining to other forms of persecution reflected a broader policy of general persecution and repression.
